

Figure 6 Goals and objectives of the Marine Fisheries Management Plan of Thailand 2020-2022




Goals

- 2. Balance between conservation and utilization of marine and coastal resources.
- 3. Comprehensive system of marine and coastal resources management.
- 4. Sufficient and viable knowledge, research, innovation, and personnel for marine and coastal resources management.



Objectives

- 1. To conserve, protect, prevent, and restore marine and coastal resources.
- 2. To develop mechanisms, tools, and regulations for marine and coastal resources management.
- 3. To promote multi-sectoral cooperation and integration for marine and coastal resources management.





Key measurement measures

- Measure 1: Preserve, protect, and restore ecosystem and marine & coastal resources.
- Measure 2: Sustainably integrated management of marine and coastal resources utilization.
- Measure 3: Enhance the effectiveness of marine and coastal resources management mechanism with emphasis on participation and keeping up with changes.
- Measure 4: Strengthen international cooperation on the basis of mutual benefit.



Priority Projects

- 1. Conservation and utilization of mangrove resources.
- 2. Marine debris and marine pollution management.
- 3. Coastal erosion management.
- 4. Conservation, restoration, and utilization of marine resources.
- 5. Promotion of cooperation, knowledge hub, and research.
